# Mental Capacity Act (MCA) – Module One Briefing Capacity: The Key Points (The Mental Capacity Act 2005)

Additionally, where an individual lacks capacity, we look to empower them to participate in decisions about their health, welfare and finances. The content of this course also considers how to assess capacity by referring to the principles in the Mental Capacity Act (2005) such as the use of restraint, advanced decision to refuse treatment and Lasting Powers of Attorney (LPA).
